You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

The Fund is a sub-fund of Invesco Zodiac Funds (the "Umbrella Fund"), a mutual fund organized under the laws of the Grand-Duchy of Luxembourg. It qualifies as an alternative investment fund (AIF) under the Luxembourg law of 12 July 2013 on AIF managers.

Term

The Fund does not have a targeted closure date and may be liquidated at any time, as further detailed in the Prospectus.

Objectives

- The objective of Invesco European Senior Loan Fund (the "Fund") is to provide a high level of current income, consistent with the preservation of capital.
- The Fund is actively managed and is not constrained by its benchmark, Credit Suisse Western European Leveraged Loan Index (Total Return), which is used for comparison purposes. However, as the benchmark is a suitable proxy for the investment strategy, it is likely that some of the issuers in the Fund are also components of the benchmark. As an actively managed fund, this overlap will change and this statement may be updated from time to time.
- The Fund has broad discretion over portfolio construction and therefore it is expected that over time the risk return characteristics of the Fund may diverge materially to the benchmark.
- Please refer to the past performance of the Fund published on the website of Invesco Management S.A, where a benchmark will be displayed if relevant.
- The Fund will invest at least 75% of the actually invested assets ("primarily") in senior loans ("Senior Loans"). In addition, the Fund will invest primarily in investments denominated in Euro, Sterling and other European currencies.
- Senior Loans include all secured debt, including but not limited to first lien loans, second lien loans, delayed draw term loans, revolving loans, collateralized loan obligations, debtor in possession loans, bridge loans, exit term loans, mezzanine loans, senior fixed rate bonds, floating rate notes, second lien bonds, and other forms of senior secured loans and bonds.
- The Fund may invest up to 25% of the actually invested assets in unsecured debt such as senior unsecured loans, senior unsecured bonds, subordinated notes and subordinated bonds. In addition, the Fund may invest in any other investment deemed appropriate to help achieve the objective, including equity and equity related securities.
- The Fund may gain exposure through derivatives (complex instruments) in order to reduce risk or to meet the Fund's investment objectives, and its total exposure can be up to 4 times the value of the Fund using the AIFM Gross Method or can be up to 2 times the value of the Fund using the AIFM Commitment Method. Details on the calculation methods can be found in the Prospectus.
- The Fund will maintain diversification across multiple borrowers from across multiple industries.
- You can buy and sell units in the Fund on any business day as further specified in the Prospectus.
- Any income from your investment will be paid monthly.

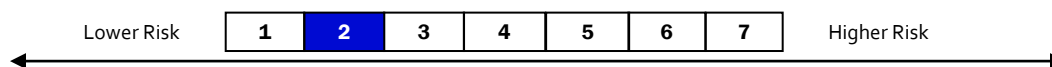

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes that you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

You may not be able to sell your product easily or you may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class.

This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the capacity of the PRIIPs manufacturer to pay you.

Be aware of currency risk. In some circumstances, you may receive payments in a different currency from your local currency, so the final return you will get may depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Other risks such as Senior Loans, European Senior Loans and Derivatives risks may impact the Fund. Please refer to the Prospectus for more details.

This product does not include any protection from future market performance so you could lose some or all of your investment.

Senior loans may be illiquid and more difficult to sell quickly at a fair price.

Because of the risk of illiquidity of the instruments in which the product will invest, the processing of the redemption requests may be deferred in certain circumstances.

Interest rates on senior loans depend on the level of an underlying rate; as such, they may change and cause fluctuations in the net asset value of the product.

When investing in instruments denominated in a currency other than its base currency, the product may be subject to foreign exchange risk which is the risk of an investment's value changing due to changes in currency exchange rates.

Senior loans are exposed to credit risk which is the ability of the borrower to repay the interest and capital on the scheduled dates.

The product will hold debt instruments which are of lower credit quality and may result in larger fluctuations in the value of the product.

The product may use derivatives (complex instruments) in an attempt to reduce the overall risk of its investments or reduce the costs of investing, although this may not be achieved.

The product may also use derivatives for investment purposes. The use of derivatives may result in the product being significantly leveraged and may result in large fluctuations in the value of the product.

The product may invest in developing markets, this may cause large fluctuations in the net asset value of the product.

Performance Scenarios

The stress scenario shows what you might get back in extreme market circumstances.

The unfavourable scenario occurred for an investment in the benchmark between October 2021 and October 2022.

The moderate scenario occurred for an investment in the benchmark between September 2013 and September 2018.

The favourable scenario occurred for an investment in the benchmark between October 2012 and October 2017.

What happens if Invesco Management S.A. is unable to pay out?

The assets of the Fund are segregated from those of Invesco Management S.A.. In addition, State Street Bank International GmbH, Luxembourg Branch, as the depositary of Invesco Zodiac Funds (the "Depositary"), is responsible for the safekeeping of the assets of the Fund. To that effect, if Invesco Management S.A. defaults, there will be no direct financial impact on the Fund. In addition, the Fund's assets shall be segregated from the Depositary's assets, which limits the risk for the Fund suffering some loss in case of default of the Depositary. As a unitholder in the Fund, there is no compensation or guarantee scheme in place.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year, you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

We have selected 5 years as the product invests for the long term.

You can sell your units in the product on any Dealing Day as defined in the Prospectus, by using one of the methods described in the Prospectus.

If you sell some or all of your investment before 5 years the product will be less likely to achieve its objectives, however, you will not incur any additional costs by doing so.
