Objectives and investment policy

Objectives

The fund aims to provide an income distribution of 4% to 6% per annum and capital growth over a market cycle by investing in a diversified range of assets and markets worldwide. The fund aims to provide a volatility (a measure of how much the fund's returns may vary over a year) of between 8- 16% per annum. *For the target return after fees for each Share Class please visit the Schroder website

Investment policy

The fund invests at least two-thirds of its assets directly in equities, bonds and alternative asset classes of emerging markets countries worldwide or companies which derive a significant proportion of their revenues or profits from emerging markets countries worldwide.

The fund may actively allocate its assets in money market instrument and currencies especially to mitigate losses in falling markets.

The fund may invest:

- in excess of 50% of its assets in sub-investment grade bonds (being bonds with a credit rating below investment grade as measured by Standard & Poor's or any equivalent grade of other credit rating agencies) and unrated bonds. - up to 20% of its assets in asset backed securities and mortgage-backed

Risk factors

Benchmark

The income and volatility targets have been selected because the investment manager deploys strategies that aim to deliver the level of income stated in the investment objective.

Dealing frequency

You may redeem your investment upon demand. This fund deals daily. **Distribution policy**

This share class accumulates income received from the fund's investments, meaning it is kept in the fund and its value is reflected in the price of the share class.


